Update on the Integration of K2fly's Infoscope solution and SAP's Cloud Based Enterprise Resource Planning System

Highlights

- The K2fly and SAP team at the SAP Co-Innovation Lab (COIL) have now completed the second phase of integrating the Infoscope Land Management System into the SAP S/4 HANA ecosystem
- Project is being delivered on time and within budget
- Infoscope addresses an unmet need for a comprehensive land management system within the resources industry
- More than 770 mining customers use SAP, including 17 of the world's top 20 mining companies

K2fly Limited (ASX:K2F) (**K2fly** or **the Company**) has reached another significant milestone on its collaboration journey with the global ERP vendor SAP. SAP is a dominant player in the enterprise software space, with a large number of mining clients.

K2F partnered with SAP in October 2017 and has been working to port its Infoscope Land Management Solution to the latest SAP S/4 HANA environment. K2F has been working in concert with an SAP team at their Co-Innovation Lab (COIL) in Germany.

Completion of the first phase resulted in Infoscope running on SAP HANA Platform. The second phase of development has been completed as planned by March 31, and further embeds K2F's Infoscope into the SAP ecosystem. This phase has been successfully extended to natively collaborate with data from SAP S/4 HANA using SAP Cloud Platform's Cloud Integration capability.

This allows SAP and K2F to address a pressing industry need around comprehensive land management by taking Infoscope to the entire SAP mining customer base. K2F and SAP are currently working out the commercial structure of this innovative solution being delivered through the SAP ecosystem. This should allow the SAP salesforce to deliver K2F's Infoscope solution as part of their product portfolio.

Mr. Georg Gradl, Global Vice President - Head of Mining & Metals, SAP, commented "At SAP, we are excited by the continued success of K2fly's SAP COIL (Co-Innovation Lab) project as they hit another significant milestone. K2fly's Infoscope Land Management System is a much-needed industry solution that has the potential to benefit every SAP customer in the mining industry globally. The SAP COIL participation allows K2fly's Infoscope solution to integrate into the SAP ecosystem, enabled by the best innovative minds across SAP."

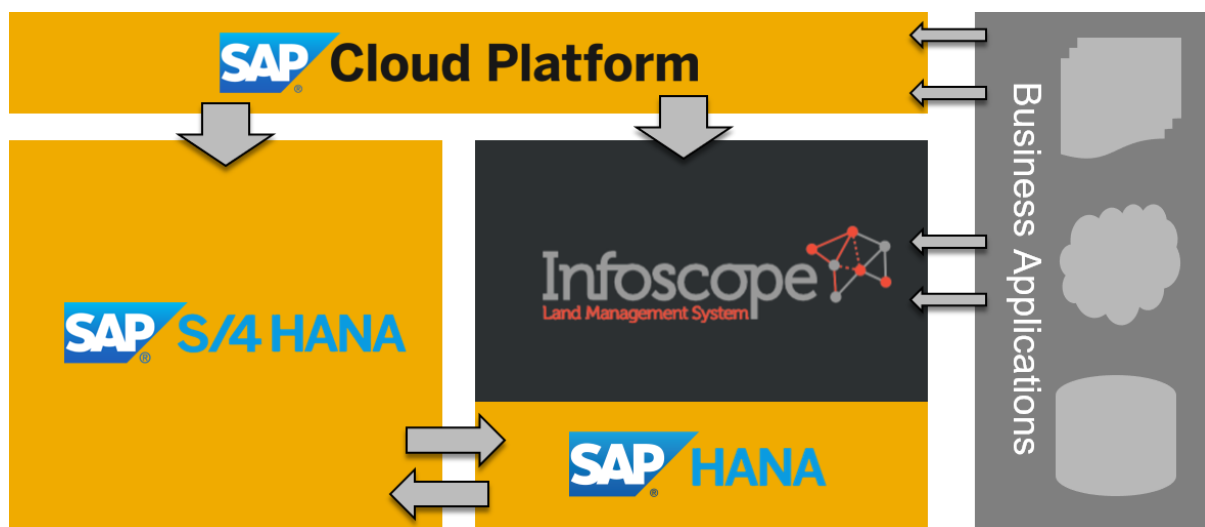
