Issue of Securities

K2fly Limited (**K2F** or **the Company**) advises that a total of 6,250,000 fully paid ordinary shares (**Shares**) have been issued. These Shares were issued pursuant to the share placement to institutional and sophisticated investors raising \$1,000,000 before costs, as announced 18 September 2019.

The Shares were issued using K2F's existing 15% placement capacity under ASX listing rule 7.1 and therefore shareholder approval was not required.
